3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Livestock farm worker are:

Core task 1: Is responsible for agribusiness product

- 1.1 Is responsible for the quality of the agribusiness product
- 1.2 Is responsible for machinery, equipment and technical installations
- 1.3 Is responsible for company buildings and grounds
- 1.4 Is responsible for information in the chain

Core task 2: Takes care of production and livestock

- 2.1 Cares for production animals and supervises
- 2.2 Cares for animal production and supervises
- 2.3 Takes care of feed production and supervises

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Livestock farm worker carries out routine tasks in the care of production animals and feed crops. He works on a production farm that keeps animals for milk, meat, breeding, eggs, fur or a combination.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications.
