3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Socio-cultural worker are:

The Socio-cultural worker organises activities and projects with groups of varying ages and from different socioeconomic and cultural backgrounds. He focuses on social participation, with a view to increasing the independence and selfreliance of the target group, and improving their residential, working and living climate.

The Socio-cultural worker has the capacity to assess individuals and groups (like associations), and has the ambition of ensuring that they all make the most of their opportunities. He has a positive basic image of people, believes in the openness of individual groups and associations to influence, and aims to use that influence to improve the quality of life.

The Socio-cultural worker focuses on a particular area (neighbourhood, district or village) or a whole metropolitan area in respect of a particular population group. He works in or from community buildings, with a combination of community centre-based and outreach work. He can also be deployed in community activities in the field of informal care.

The Socio-cultural worker is primarily active in the following areas:

- recreation, sport and play;

- art, culture and amusement;

- education and citizenship.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Socio-cultural worker is employed as a social care worker, youth worker, club leader, (sport) community centre worker, development worker in community centres, playgrounds, youth centres, women's centres, centres for adult education, centres for immigrants or asylum seekers centres.

International agreements The profession of Socio-cultural worker is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
