Core task 3: Carries out the staff policy

- 3.1 Gives advice about the staffing needs
- 3.2 Recruits and selects colleagues
- 3.3 Supervises and assesses colleagues

Core task 4: Maintains business contacts

- 4.1 Manages business relationships
- 4.2 Carries out acquisition
- 4.3 Makes suggestions for contracts
- 4.4 Deals with complaints

The Logistics supervisor works for logistic service providers, wholesale trades that belong to the small-scale business (a maximum of 10 employees), production businesses, or transport companies.

<p>Access to next level of education/professions Within the sector logistics, the Logistics supervisor can be promoted to the position of logistics manager. He can do a higher vocational education for this. Within the higher vocational education, the programme for Logistics management is a logical follow-up.</p>	<p>International agreements The profession of Logistics supervisor mobility sector is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 90212 The education and training for this qualification is offered as of August 1, 2009.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
