3. Profile of skills and competences

The most important duties of a Technical specialist commercial vehicles are:

Core task 1: Carries out repairs to commercial vehicles

- 1.1 Prepares the repair assignment in workplace or on location
- 1.2 Carries out repairs to commercial vehicle in the workplace
- 1.3 Determines diagnosis of commercial vehicle on location
- 1.4 Carries out (emergency) repairs to commercial vehicle on location
- 1.5 Inspects the repair work and completes the assignment
- 1.6 Supports and instructs colleagues in their repair working duties
- 1.7 Gives technical information and advice about repair to client/ driver
- 1.8 Is responsible for sharing knowledge about repair situations within the business

Core task 2: Determines diagnosis concerning commercial vehicles

- 2.1 Prepares diagnosis assignment
- 2.2 Determines diagnosis of commercial vehicle in the workplace
- 2.3 Inspects and completes diagnosis working duties
- 2.4 Supports and instructs colleagues in their diagnosis working duties
- 2.5 Supervises colleagues by the determination of diagnosis on location
- 2.6 Is responsible for sharing knowledge about diagnosis situations within the business

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The mobility sector consists of companies that sell, rent, maintain, and repair passenger and company cars, caravans, trailers, scooters, bicycles, motor cycles, and mopeds. This is including towing and salvage companies, petrol stations, and carwashes.

Access to next level of education/professions

Having completed this course of studies, transfer is possible to higher professional education.

The Technical specialist commercial vehicles can attend higher vocational education, choosing between Car technology, Mechanical engineering, Electrical engineering, and Business management.

International agreements

The profession of Technical specialist commercial vehicles is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (ymbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
