- 1.4 Determines treatment
- 1.5 Organises the workplace
- 1.6 Handles horses
- 1.7 Trims
- 1.8 Makes horseshoes
- 1.9 Nails on horseshoes
- 1.10 Cleans the workplace

Core task 2: Runs a business

- 2.1 Starts up a business
- 2.2 Determines and monitors policy concerning quality, working conditions, environment and safety
- 2.3 Determines marketing mix
- 2.4 Determines tariffs
- 2.5 Promotes the business
- 2.6 Identifies and deals with complaints
- 2.7 Monitors and is responsible for financial situation
- 2.8 Manages business administration
- 2.9 Purchases
- 2.10 Monitors stock

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Farrier is a service provider in that he carries out specialized works for his clients, on the hoofs of horses and ponies. Usually, the Farrier works as a self-employed entrepreneur without any staff. Sometimes the Farrier works for stables, an equestrian sports company, or a veterinary or animal clinic.

<p><b>Access to next level of education/professions</b> After gathering experience and specialization, the Farrier can develop into a specialist. In addition to trimming and shoeing, the specialist therapeutically and remedially shoes horses and ponies with a deviant stance, infirmity in the legs, or ailments of the hoof.</p>	<p><b>International agreements</b> The profession of Farrier is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 97510 The education and training for this qualification is offered as of August 1, 2009.</p>																					

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
