The most important duties of a Skilled car spray painter is:

The Skilled car spray painter is capable of repairing damaged car layers perfectly and is also capable to give entire coachworks a new smooth lacquer. Simple disassembly and assembly activities belong to this trade. Sometimes parts must be removed (and later again assembled) to spray them accurately. The skilled car spray painter is also capable in calculating the costs of the job.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
