## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Deck officer water engineering are:

Core task 1: Navigation

- 1.1 Makes up travel preparations
- 1.2 Keeps the navigation watch
- 1.3 Manoeuvres the boat and reacts to nautical emergencies
- 1.4 Operates technical sailing and technical dredging systems

Core task 2: Cargo handling and stowage

- 2.1 Is responsible for the loading, transport and unloading of the cargo
- 2.2 Optimises the dredging process
- 2.3 Reports about the dredging process

Core task 3: Controlling the operations of the ship and care for persons on board

- 3.1 Is responsible for the safety and compliance with environmental and legal requirements
- 3.2 Is responsible for the seaworthiness of the boat
- 3.3 Stays and works on board

Core task 4: Safety

- 4.1 Identifies and deals with calamities and accidents on board
- 4.2 Manages and is in charge of life-saving vessels during launching and afterwards
- 4.3 Provides medical assistance in case of accidents and medical care for the sick
- 4.4 Organises fire-fighting operations on board
- 4.5 Carries out maritime communication

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Deck officer water engineering works for a contractor's firm in the water construction. These companies focus on performing dredging works, both on inland waters and offshore and/or on performing works on shores and banks in ports or along rivers and canals.

<b>Name and status of the body awarding the certificate</b> The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.	<b>Name and status of the national/regional authority providing accreditation/recognition of the certificate</b> Ministry of Education, Culture and Science
<b>Level of the certificate (national or international)</b> Qualification level 4 of the Dutch VET qualification structure Characteristics: non-job related skills such as tactical and strategic capacities. The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. The range of tasks also includes drafting new procedures. <b>Access to next level of education/professions</b> The Deck officer water engineering can be promoted to captain and possibly to the position of operator of the dredging company. He can develop in project management.	<b>International agreements</b> The profession of Deck officer water engineering is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.
<b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 93102 The education and training for this qualification is offered as of August 1, 2009.	

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

<b>Average duration of the education/ training leading to the certificate</b>	<b>4 years (6400 study hours) (depending on previous education)</b>
<b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
