3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Supervisor phonotics are for each specialisation:

- Video engineering:
 - (jointly) developing video products;
 - carrying out specific technical tasks (camera operation, picture technique, editing);
- Photography:
 - independently developing photographic products;
- Opto engineering:
 - using, developing, testing and maintaining (optical) measure and analysis equipment.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Supervisor phonotics independently carries out activities in fields where light is used as a carrier for energy or information. The central focus is on the underlying technology rather than the artistic aspects.

There are 3 possible specialisations:

- Video engineering is aimed at recording and processing moving pictures and sound. Possible jobs include cameraman, picture technician or editor in an AV company;
- Photography is aimed at capturing and editing non-moving images and sound. Possible jobs include public photographer, research photographer, medical photographer and advertisement photographer;
- Opto engineering is aimed at the use and development of optical equipment. Possible jobs include laser engineer, optical laboratory employee or employee technical service.

International agreements The profession of Supervisor phonotics is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).</p> <p>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.</p> <p>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
Average duration of the education/ training leading to the certificate	4 year(s) (6400 study hours) (depending on previous education)
Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
