Profile of skills and competences

The most important duties of a Boatman are:

Core task 1: Is responsible for the positioning, mooring, casting off and shifting of (sea-going) boats/ work vessels

- 1.2 Inspects materials
- 1.3 Repairs materials
- 1.4 Cleans materials
- 1.5 Positions (sea-going) boats/ work vessels
- 1.6 Moors (sea-going) boats/ work vehicles
- 1.7 Casts off (sea-going) boats/ work vessels
- 1.8 Shifts (sea-going) boats/ work vessels
- 1.9 Supervises trainees in the positioning, mooring, casting off and shifting of (sea-going) boats/ work vessels

Core task 2: Transports people, goods and floating objects within the working area

- 2.1 Consults with the planning department
- 2.2 Transports people within the working area
- 2.3 Transports goods within the working area
- 2.4 Supervises divers during diving working duties
- 2.5 Moves and sets floating objects fast
- 2.6 Supervises trainees in transporting people, goods and floating objects within the working area

Core task 3: Works on board (sea-going) boats/ work vessels

- 3.1 Consults with the planning department
- 3.2 Acts as crew during mooring, casting off and shifting of (sea-going) boats/ work vessels
- 3.3 Carries out inspections and repairs on board (sea-going) boats/ work vessels
- 3.4 Steers the boat/ work vessel according to rudder commands
- 3.5 Supervises trainees in their work on (sea-going) boats/ work vessels

Core task 4: Assists in cases of calamities

- 4.1 Consults with the planning department
- Assists by oil spills
- Assists with boats gone adrift

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Boatman works in an organization or association in a port area or sluice. This organization assists (oceangoing) vessels 24 hours a day.

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

Access to next level of education/professions

In due course, the Boatman will supervise trainees and function as a helmsman or captain on various vessels. The Boatman can do the intermediate vocational training for Captain inland. In addition, the Boatman can switch to positions on shore or with nautical service providers such as pilot boat and tow boat organizations. He can also switch to the position of captain inland navigation.

International agreements

The profession of Boatman is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 93030 The education and training for this qualification is offered as of August 1, 2009.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways; the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
