## 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Last maker are:

Core task 1: Builds up orthopaedic footwear provisions

- 1.1 Carries out preparatory work for the manufacture of orthopaedic footwear provisions
- 1.2 Makes inlays or supplements
- 1.3 Makes rehabilitation, bandage or orthopaedic fitted footwear
- 1.4 Makes footwear linings, orthoses or prostheses
- 1.5 Makes orthopaedic provisions fitted into mass-produced footwear
- 1.6 Finishes off orthopaedic provision and carries out final inspection

Core task 2: Makes lasts

- 2.1 Carries out preparatory work for making lasts
- 2.2 Models and make prefabricated lasts
- 2.3 Models and make cast lasts
- 2.4 Carries out final inspection of lasts

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Last makers work in orthopaedic footwear companies. These companies focus on measuring and producing orthopaedic custom-made footwear and orthopaedic footwear accessories.

#### Access to next level of education/professions

Obtaining the diploma of Last maker gives access to the programme for Orthopaedic footwear technician at level 4.

#### International agreements

The profession of Last maker is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

#### Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 94700  
The education and training for this qualification is offered as of August 1, 2009.

### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

**3 year(s) (4800 study hours) (depending on previous education)**

#### Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
