- 2.4 Registers and completes sale/ repair
- 2.5 Deals with complaints
- 2.6 Presents articles

Core task 3: Provides professional qualities to their business

- 3.3 Innovates the business
- 3.4 Promotes and profiles the business
- 3.5 Monitors the financial situation and is responsible for this

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Shoe repairer/entrepreneur work in shoe repairer companies. These are mostly small companies comprising of one to a few employees.

<p>Access to next level of education/professions With the certificate of Shoe repairer/entrepreneur, transfer is possible to a middle management or specialist course (qualification level 4). Shoe repairer/entrepreneurs can work as self-employed entrepreneurs. By obtaining additional certificates and diplomas, Shoe repairer/entrepreneurs can specialize in repairing orthopaedic shoes and fitting orthopaedic footwear provisions.</p>	<p>International agreements The profession of Shoe repairer/entrepreneur is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
