It could be at a company that develops and sells collections and brands under its own label and/or commissions the production and sale of collections ('private label').

<p>Access to next level of education/professions With a Fashion product coordinator diploma, transfer is possible to higher vocational education, for example to: a 4-year fulltime study programme as fashion designer specialising in 'Textile concept development' (Royal Academy for Visual Arts in The Hague), a 2-year part-time study programme in Styling and Fashion Design specialisation in 'interior styling' (Artemis), a 4-year fulltime fashion study programme specialising in 'design' or 'management' (AMFI) or a 3.5-year higher professional education study programme training candidates for commercial management positions in the fashion and lifestyle sector (TMO Doorn).</p>	<p>International agreements Fashion product coordinator is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
