The Skilled spray painter works in industrial paint processing/coating, furniture industry or timber construction. He works on metal, wood or synthetic construction, such as machines, furniture, domestic goods, bicycles & body work, (store) interiors and construction elements (window frames, doors stairs, etc.).

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
