3. PROFILE OF SKILLS AND COMPETENCES

The most important tasks of a Mechanical operator B are:

- independently monitoring and regulating production processes on the basis of a thorough understanding of the various variables influencing the process;
- operating complex production installations:
- (ordering) the taking and assessing of samples and carrying out investigations:
- implementing process calculations;
- reporting orally and in writing about the status of the process;
- undertaking simple maintenance;
- identifying and correcting commonly-occurring disruptions;
- assisting in complex maintenance and conversion activities.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The professional field process technology encompasses operative and middle management professions in the process industry. In the process industry, products are manufactured according to processes, i.e. step-by-step and often with automatically-operating equipment. Examples of the process industry are the (petro) chemical industry, paper and paper products industry, rubber and plastic processing industry, energy generation companies, pharmaceutical industry, etc. The Mechanical operator B monitors and regulates complex production processes and operates complex production installations. The Mechanical operator B is specifically expert in the field of mechanical/physical processes. The Mechanical operator B is involved in actions involving the production equipment (setting and conversion) rather than the remote operation of these systems. A Mechanical operator B can occupy various positions within an organisation, for example panel operator and chief operator.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
