- 1.4 Performs measurements and tests
- 1.5 Reports inspection
- 1.6 Instructs and supervises less experienced colleagues

Core task 2: Optimizes equipment/installations and repairs failures

- 2.1 Prepares work
- 2.2 Takes precautions
- 2.3 Localizes and analyzes (cause of) failure
- 2.4 Determines (nature and proportions) of work that has to be done
- 2.5 Repairs, removes and mounts components
- 2.6 Tests performed work
- 2.7 Instructs and supervises less experienced colleagues

Core task 3: Makes equipment/installations ready for use

- 3.1 Sets and checks equipment/installations
- 3.2 Reports work
- 3.3 Hands over to client
- 3.4 Instructs and supervises less experienced colleagues

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Service technician electrotechnology works in production, installation and service companies. The Service technician electrotechnology repairs failures in electro technical machines, equipment and installations, consumer electronics, office equipment and electro technical consumer commodities.

<p><b>Access to next level of education/professions</b> This programme gives access to higher vocational education. Technical/physics hbo programmes such as Electro technique, Technical business administration, Industrial product design and Mechanical engineering would seem the most obvious choice. Via labour market and training, the Service technician electrotechnology can move up to specialist or manager in the field of electrotechnology. Other prospects are broadening from the original technical field to another field; for example broadening from electrotechnology to air conditioning technique or moving up to designer/production developer/project leader, service coordinator/service manager, contract manager and contract manager (hbo).</p>	<p><b>International agreements</b> The profession of Service technician electrotechnology is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 94331 The education and training for this qualification is offered as of August 1, 2008.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
