3. Profile of skills and competences

The most important duties of a Dental nurse are:

The Dental nurse assists the treating dentist in preparing, implementing and concluding dental treatment, to ensure that treatments can be undertaken efficiently and effectively. The Dental nurse independently completes dental part treatments, within the applicable legislation and regulations, and provides information, advice and instruction to the care recipient, in accordance with working instructions.

The Dental nurse is responsible in the broadest sense for the smooth running of the organisation in the dental practice. The Dental nurse operates independently and/or as part of a team. The professional attitude of the Dental nurse is critical and communicative, and is characterised by expertise, empathy, efficiency, friendliness and customer-focus. Specific to the work of the Dental nurse is the fact that care recipients are often fearful. The Dental nurse is alert to such emotions, and responds suitably.

The Dental nurse is well presented and deals with the care recipients with care and respect.

The Dental nurse works according to the instructions of the employer (the dentist or dental specialist).

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Dental nurse is employed in the sector health care, in the dental division. The Dental nurse may be employed with a (general) dental practice (both individual and group practice), dental centres, health centres, hospitals, orthodontic practice, practice for differentiated dental care, regional youth dental care institutions, nursing homes, dental hygiene clinics, dental training courses and Centres for Special Dental Care (CBT).

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 10775

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
