# 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an All-round bricklayer are:

- facing brickwork;
- brickwork for rendering;
- producing brickwork constructions;
- gluing work and producing light-weight dividing walls;
- carrying out gluing work elements and blocks;
- erecting and removing scaffolding:
- supervising shift members;
- administration of daily activities.

The All-round bricklayer independently undertakes the most common work processes in respect of stone-like components in the field of civil and commercial building and can be broadly deployed in the sector. The All-round bricklayer is also responsible for the progress of daily activities by the work shift.

# 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The All-round bricklayer is employed by a contractor or specialist bricklaying company.

The All-round bricklayer may be employed in new building, extension or renovation work and the restoration sector.

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

## **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
