### 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Synthetics worker aircraft building are:

Core task 1: Manufactures parts for aircraft

- 1.1 Prepares his own work
- 1.2 Manufactures components for aircraft building
- 1.3 Checks and measures aircraft parts
- 1.4 Completes his work

Core task 2: Processes synthetic parts for aircraft building

- 2.1 Makes synthetic (de)forming dies
- 2.2 Processes synthetic parts
- 2.3 Checks, measures and tests aircraft parts

# 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Synthetics worker aircraft building works at a company that manufactures parts for the aircraft industry. He carries out his tasks mainly in a workshop or production hall. He processes plastic parts and then checks, measures and tests the parts.

### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
