3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an Assistant supervisor civilian, commercial and industrial construction are:

The Assistant supervisor civilian, commercial and industrial construction is often present at the construction site. Together with the construction supervisor he instructs and manages the staff at the construction site. He allocates the activities over the crew, the subcontractors and the installers. At small projects he is the construction supervisor. The Assistant supervisor keeps an eye at the safety precautions and arranges that everything will be finished in time. He supplies the right materials at the right time and place. In addition to the work at the construction site he is also present at the construction meetings and performs office work such as keeping up the costs to date and planning for the staff.

5. OFFICIAL BASIS OF THE CERTIFICATE

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
