3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Skilled mechanic are:

Core task 1: Carries out maintenance work on aircraft, aircraft components and systems

- 1.2 Prepares the aircraft ready for maintenance
- 1.3 (Dis)assembles, modifies and replaces parts, components and systems
- 1.4 Finishes off the maintenance working duties

Core task 2: Inspects and tests aircraft parts, components and systems

- 2.1 Prepares the inspection and testing working duties
- 2.2 Carries out inspections and tests
- 2.3 Analyses and repairs mistakes and defects
- 2.4 Finishes off the working duties

Core task 3: Carries out inspections on aircraft

- 3.1 Prepares the inspection working duties
- 3.2 Carries out the inspection
- 3.3 Finishes off the working duties

Core task 4: Manages and authorises working duties

- 4.1 Conducts work meeting
- 4.2 Supervises colleagues in carrying out their working duties
- 4.3 Inspects the work that has been carried out
- 4.4 Authorises the work that has been carried out
- 4.5 Administers the authorised work

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Skilled mechanic mainly works for large companies that deal with aircraft maintenance, such as airline companies or a maintenance repair organisation for aeroplanes and/or aeroplane parts.

<p>Access to next level of education/professions With the certificate of Skilled mechanic, transfer is possible to a middle management or specialist course (qualification level 4). Based on experience, refresher and advanced training, the Skilled mechanic can rise to the position of, for instance: - First engineer part-66 cat-A1 turbo-charged winged aircraft; - First engineer part-66 cat-A2 piston-engine winged aircraft; - First engineer part-66 cat-A3 turbo-charged helicopters</p>	<p>International agreements The profession of Skilled mechanic is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
