# 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Plasterer are:

- to inspect, clean and prepare surfaces;
- level and straighten corners, angles, and wall and ceiling surfaces;
- mix and apply coats of plaster, cement, render or similar materials to walls and ceilings;
- apply finishing coats of plaster to give a smooth finish or decorative texture;
- plaster exterior walls and moulds.

The Plasterer is responsible for his work that consists of applying plaster on walls and ceilings and applying plaster outdoors.

The Plasterer chooses during the education one of the following specialisations:

- Mechanic plasterer;
- Spouting plaster;
- Adjusting blocks and elementary components;
- Thermic (house)front isolation.

### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
