His main activities are activities concerning the management including personal and staff and controlling the work activities of employees. The manager takes decisions independently. He performs, where necessary, executive tasks. In the field of administration and staff matter he is mostly supported by an expert. He is responsible for the continuity of the company and supervises employees. The Manager is responsible for translating the wishes of the consumers and customers into a qualitatively good product, which meets the standards of the consumers and customers. The Manager carries out all these activities with the emphasis on planning and evaluation, as well for, maintaining the quality of the products and the maintenance of machines . He carries out a risk identification and evaluation. He makes agreements with customers and suppliers. The Manager has the final responsibility.

#### 5. OFFICIAL BASIS OF THE CERTIFICATE

With a diploma at qualification level 4, transfer is possible to higher professional education.

The profession of Manager wholesale business and logistics is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

#### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
