3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Sound technician are:

Core task 1: Develops a concept and/or plan for the client

- 1.1 Consults about the wishes of the client
- 1.2 Carries out location investigations
- 1.3 Formulates concept and/or plan
- 1.4 Discusses concept and/or plan with the client
- 1.5 Makes a technical plan

Core task 2: Realises lighting, images and/or sound

- 2.1 Gathers together and transports audiovisual material and apparatus
- 2.2 Assembles and disassembles audiovisual material and apparatus
- 2.3 Resolves malfunctions
- 2.4 Improves the acoustics
- 2.5 Operates image, light and/or sound apparatus by productions/ projects
- 2.6 Makes sound recordings
- 2.7 Applies special image, light and/or sound techniques/ effects

Core task 3: Processes audiovisual material

- 3.1 Installs hardware and software for processing images
- 3.2 Makes recordings ready for editing

Core task 4: Maintains and manages audiovisual material and apparatus

- 4.1 Inspects audiovisual material and apparatus and carries out simple maintenance
- 4.2 Manages image and sound carriers and the archives
- 4.3 Organises the users' rights

Core task 5: Leads projects

- 5.1 Manages the project team
- 5.2 Monitors the progress of the project

Core task 6: Carries out entrepreneurial tasks

The Sound technician works in the audiovisual sector. The audiovisual sector produces audiovisual productions such as video productions, television, and film, photographs, and sound recordings.

<b>Level of the certificate (national or international)</b> Qualification level 4 of the Dutch VET qualification structure Characteristics: non-job related skills such as tactical and strategic capacities. The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. The range of tasks also includes drafting new procedures. <b>Access to next level of education/professions</b> Entering higher vocational education is possible. Promotion is also possible to managerial positions such as (assistant) production manager, project leader, coordinator, director, or starting your own company.	<b>International agreements</b> The profession of Sound technician is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.
<b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 90085 The education and training for this qualification is offered as of August 1, 2009.	

### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
