#### 3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Skilled large green worker are:

Large green areas include parks, woodlands, nature conservation areas, sports fields and recreation grounds. All such large green areas must be designed, laid out, maintained and managed. Soil and water play a role in these processes. Possibilities include delivery and removal of soil, sewerage systems, drainage, preparation and finishing of the soil on sites where building is to be carried out or where green facilities are to be laid out, soil remediation, etc. This involves much work with machines and installations. A degree of land measurement must also be undertaken. All aspects of working in and with large green areas are part of the work of a Skilled large green worker

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Skilled large green worker may be employed with recreation and leisure boards, municipalities, provinces, water boards, the Forestry Commission, water supply companies and nature conservation organisations. He may also start your own business.

5. OFFICIAL BASIS OF THE CERTIFICATE		
With a diploma at qualification level 3, transfer is possible to a course at qualification level 4.	The profession of Skilled large green worker is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

# 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

## **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
