3. Profile of skills and competences

The most important duties of a Social pedagogical carer are:

The Social pedagogical carer will provide educational supervision to the individual and the group in residential and living situations, whereby the self-reliance of the individual will be encouraged as far as possible. He/she draws up, implements and evaluates a care plan (personal plan).

He/she will carry out the tasks on the basis of specific methods. The professional character of the care and service provision is expressed in a planned, targeted and method-based approach. The Social pedagogical carer is responsible for establishing and implementing the activities, interventions and for interpreting and recording the effects. During these activities, observations are made and as necessary reports issued. The Social pedagogical carer is able to bear responsibility for the organisation of care and service provision for individual care recipients and for situation-specific tasks such as profession and organisation-related tasks. He/she is able to consult with representatives from his/her own discipline and other disciplines.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Social pedagogical carer/group leader/group worker may be employed in care for the disabled, juvenile aid, child care, care for the aged, hospitals (including psychiatric hospitals), prisons, sheltered workshops. The Social pedagogical carer worker in extremely diverse settings: within ambulant, semi-residential and residential work forms. These are settings where he/she will be involved with individuals who have usually been placed there upon social, legal or medical indication. The Social pedagogical carer will focus on both younger and older children, adults and senior citizens, often with a whole range of problems.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
