- 2.2 Makes the fitting
- 2.3 Carries out final inspection of model

Core task 3: Makes an entrepreneur plan and monitors the business plan

- 3.1 Defines the (future) image of the workshop
- 3.2 Shapes the business plan of the workshop
- 3.3 Manages the financial part of the workshop
- 3.4 Monitors the financial position of the workshop
- 3.5 Positions and/or innovates the workshop
- 3.6 Manages the purchasing for the workshop
- 3.7 Investigates developments in its professional area

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Those having obtained the diploma of Specialist fashion/custom made clothes are qualified to work in a workshop of a company for mass-production, custom-made clothes and clothing repair/alteration. A reconditioning company is also an option.

This document is designed to provide additional information about the specified certificate and does not have any legal status in itself. Access to next level of education/professions

After obtaining the diploma Specialist fashion/custom made clothes they can transfer to a Higher Professional Education course (hbo). Possibilities are, amongst others, a 4-year fulltime course fashion designer with specialisation Concept Development textiles (Royal Academy of visual Art in Den Haag) b. a 2-vear part time course in the field of styling and fashion design with specialism Interior styling (Artemis) c. a 4-year fulltime fashion course with specialism Design of Management (AMFI) d. a 2-year short hbo course, the Bachelor of fashion in Business, which trains for three respective specific professions in the fashion sector: purchaser, sales manager and independent entrepreneur (TMO).

International agreements

The profession of Specialist fashion/custom made clothes is not regulated in the Netherlands. However the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 95740 The education and training for this qualification is offered as of August 1, 2012.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate

4 years (6400 study hours) (depending on previous education)

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
