3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Logistics worker are:

Core task 1: Receiving and storing goods

- 1.1 Prepares reception and storage of goods
- 1.2 Unloads goods
- 1.2 Checks received goods
- 1.4 Prepares goods for storage and stores goods
- 1.5 Concludes the reception and storage of goods

Core task 2: Collecting goods and preparing them for dispatch

- 2.1 Prepares the collection and preparation of goods for dispatch
- 2.2 Collects goods
- 2.3 Carries out product-related activities (VAS activities)
- 2.4 Prepares goods for dispatch
- 2.5 Loads goods
- 2.6 Concludes the collection and preparation of goods for dispatch

Core task 3: Stock taking

- 3.1 Prepares stock taking
- 3.2 Takes stock of products
- 3.3 Enters new goods into the system

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Logistics worker is employed in all divisions of the trade and transport sector. He can for example be employed in wholesale businesses, transport companies, logistic service providers, distribution centres, warehouses and production companies. The place of work will depend on the type of work activity. This may involve dispatch work, work in the central hall or the warehouse storage area.

| 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE | |

| <p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p> | |
