The most important duties of a Scooter mechanic are:

Core task 1: Makes motorised two-wheeler ready for delivery

- 1.1 Prepares for motorised two-wheeler to be made ready for delivery
- 1.2 Performs inspection of motorized two-wheeler
- 1.3 Makes motorised two-wheeler ready for delivery
- 1.4 Completes making motorised two-wheeler ready for delivery

Core task 2: Performs maintenance on motorised two-wheeler

- 2.1 Prepares maintenance on motorized two-wheeler
- 2.2 Performs maintenance work
- 2.3 Completes maintenance on motorised two-wheeler

Core task 3: Performs repairs on motorised two-wheeler

- 3.1 Prepares repair work on motorized two-wheeler
- 3.2 Performs repair work
- 3.3 Completes repair on motorised two-wheeler

Core task 4: Sells products and services

- 4.1 Receives clients and talks to them
- 4.2 Carries out cash register operations and completes sales

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Scooter mechanic works in a scooter or motorcycle store in both the workshop and the shop.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>2 years (3200 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.</p>

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
