3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of an Advanced carpenter are:

- Positioning of measuring poles and all kinds of casings;
- Make and place formwork;
- Concreting:
- Adjusting and installing prefab elements;
- Attach roof constructions and gutters;
- Carrying out small reinforcing work;
- Carrying out carpentry work indoor and outdoor;
- Carrying out repair work and restoration work;
- Carrying out complex mechanical carpentry work;
- Supervise a small group of carpenters;
- Organisation duties for the execution of small construction works.

The Advanced carpenter is qualified to carry out most common work processes in civil, office and industrial building, independently or subject to the supervision of a foreman or (assistant) foreman, and can be widely deployed in the industry. He has a broad basic knowledge of all subjects of the profession.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Advanced carpenter can work in various positions at contractors and specialised contractors and/or in real estate management organisations.

However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
