<p>The most important duties of a Fresh produce industry worker are:</p> <p>Core task 1: Prepares the process of the production and processing of fresh products.</p> <p>1.1 Makes machines ready for use and/or sets out (packaging) materials and tools</p> <p>1.2 Receives raw materials and consumables for the production/processing of fresh products and identifies malfunctions</p> <p>1.3 Signals deficiencies in good time and passes them on</p> <p>Core task 2: Carries out production and processing of fresh products</p> <p>2.1 Treats and/or processes fresh products manually and/or with the aid of machines</p> <p>2.2 Checks fresh products during production/processing and/or monitors the production/processing of fresh products</p> <p>2.3 Removes waste and/or residual products</p> <p>2.4 Cleans and/or disinfects</p> <p>2.5 Rounds off working duties</p>

<p>The Fresh produce industry worker is above all involved in standard tasks in the production and processing of fresh food products such as meat, meat products, poultry, game, fish and also cheese, vegetables and fruit.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi).</p> <p>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.</p> <p>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p>Average duration of the education/ training leading to the certificate</p>	<p>2 years (3200 study hours) (depending on previous education)</p>
<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.</p>	

7. ADDITIONAL INFORMATION
<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The complete qualification file can be found at http://kwalificaties.s-bb.nl/, only in Dutch.</p> <p>Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration.
