- 2.9 Carries out clearing up working duties
- 2.10 Supplies plastering work

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Restoration plasterer works in small, medium and large size companies which are active in deconstruction, most specifically in the plastering field. He carries out duties for various clients: think of renovation, restoration, but also in housing construction and non-residential construction both in maintenance situations and in new buildings which aims at new and decorative plastering work. The Restoration plasterer can be employed both at the start of a restoration programme and during work which has already started during which his expertise can be used. His restoration plans can be made for both his own restoration as well as that of third parties. This goes for his designs

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
