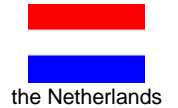

3. PROFILE OF SKILLS AND COMPETENCES
<p>The most important duties of a Haberdashery custom-made clothes worker are:</p> <ul style="list-style-type: none"> - Measuring, pattern marking and production of simple gentlemen's clothing such as trousers, waistcoat, shirt; - Measuring, pattern marking and production of ladies' clothing such as skirt, trousers, waistcoat, blouse <p>To be able to carry out these tasks, the Haberdashery custom-made clothes worker must for example fit the model, adjust the pattern, stitch, line, reinforce, fit fasteners, iron and press. He must have an understanding of fabrics and haberdashery, and interact successfully with clients.</p>

<p>Haberdashery custom-made clothes worker in a tailoring company, producer of trousers, producer of ladies' clothing.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
Average duration of the education/ training leading to the certificate	2 years (3200 study hours) (depending on previous education)
<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.</p>
