- 1.5 Handles animals
- 1.6 Registers and reports

Core task 2: Supervises reproduction

- 2.1 Supervises reproductive process
- 2.2 Supervises birth process

Core task 3: Takes care of the living and working environment

- 3.1 Organises the living accommodation
- 3.2 Cleans and disinfects
- 3.3 Maintains living and working environments

Core task 4: Carries out working duties aimed at the public

- 4.1 Provides information and explanations
- 4.2 Organises events and activities and carries these out

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Caretaker of animals for recreational purposes works in a company that keeps animals. There are companies that keep animals for semen collection, for rearing, or for the production of animals and/or animal's products. In addition, there are companies that keep animals for recreational, educational, sociocultural and/or therapeutic purposes. Finally, there are companies that keep animals for research purposes. The vocational context of animal keeper depends on the company system used.

<p>Access to next level of education/professions Career opportunities for the specialization Caretaker of animals for recreational purposes are usually found in rising to animal shelter business manager, boarding kennel business manager, kennel business manager, children's farm business manager, and zoo business manager.</p>	<p>International agreements The profession of Caretaker of animals for recreational purposes is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p>Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 97364 The education and training for this qualification is offered as of August 1, 2009.</p>																					

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
