- 1.4 Processes natural stone using machines
- 1.5 Clears up the workplace

Core task 2: Organises the daily working duties of the colleagues

- 2.1 Apportions the working duties and instructs colleagues
- 2.2 Monitors the quality and checks that instructions have been followed
- 2.3 Monitors the progress
- 2.4 Reports to supervisor

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The All-round stonemason production works in the masonry sector, consisting of small and medium-sized companies. The small companies are generally more specialised.

Access to next level of education/professions With the certificate of professional training, transfer is possible to a middle management or specialist course (qualification level 4). After training, a diploma can be obtained in other specializations at level 3. In addition to broadening at level 3, it is possible to develop into a management position, such as planning officer or workshop manager. The All-round stonemason production can develop into the qualification for Supervisor construction, infrastructure and specialised contracting.	International agreements The profession of All-round stonemason production is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.
Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 94801 The education and training for this qualification is offered as of August 1, 2009.	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
