3. PROFILE OF SKILLS AND COMPETENCES

The most important duties of a Dental assistant prosthetics are:

Core task 1: Carries out basic technical dental duties in order to reproduce the situation in the patient's mouth

- 1.1 Prepares basic technical dental working duties
- 1.2 Makes temporary plaster models
- 1.3 Makes individual impression moulds
- 1.4 Makes permanent plaster models
- 1.5 Makes bite plates and assembles registration equipment
- 1.6 Assembles plaster models in articulator
- 1.7 Inspects and registers basic technical dental equipment

Core task 2: Makes dental prostheses

- 2.1 Prepares the manufacture of tooth prostheses
- 2.2 Makes test set-up of partial tooth prostheses and models the frame section
- 2.3 Translates model of the frame section into permanent restoration materials
- 2.4 Sets up and completes the modelling of tooth elements in partial and full tooth prostheses
- 2.5 Translates model of the partial or full tooth prostheses into synthetic material
- 2.6 Inspects, finishes off and polishes synthetic partial or full tooth prostheses
- 2.7 Repairs partial or full tooth prostheses
- 2.8 Inspects and registers tooth prostheses

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Dental assistant prosthetics works in an independently established technical dental business or in a business that is part of a collaborative partnership. The business can also be affiliated to a dentist's or a practice for dental prosthetics.

Access to next level of education/professions With the certificate of Dental assistant prosthetics, transfer is possible to a middle management or specialist course (qualification level 4). After prosthetics, a Dental assistant can broaden to the direction of crowns and bridges. In addition, after having worked a number of years in employment, the Dental assistant prosthetics can rise to become a manager. He can also do the programme for Dental technician/manager crowns and bridges or Dental technician/manager prosthetics.	International agreements The profession of Dental assistant prosthetics is not regulated in the Netherlands. However the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.
Legal basis Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 94712 The education and training for this qualification is offered as of August 1, 2009.	

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE	
Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
